Step 2 - "We came to believe that a power greater than ourselves could restore us to sanity."

Who cares to admit complete defeat? Practically no one, of course. Every natural instinct cries out against the idea of personal powerlessness. It is truly awful to admit that, glass in hand, we have warped our minds into such an obsession for destructive drinking that only an act of providence can remove it from us. No other kind of bankruptcy is like this one. Alcohol, now become the rapacious creditor, bleeds us of all selfsufficiency and all will to resist its demands. Once this stark fact is accepted, our bankruptcy as going human concerns is complete. But upon entering A.A. we soon take quite another view of this absolute humiliation. We perceive that only through utter defeat are we able to take our first steps toward liberation and strength. Our admissions of personal powerlessness finally turn out to be firm bedrock upon which happy and purposeful lives may be built. Why all this insistence that every A.A. must hit bottom first? The answer is that few people will sincerely try to practice the A.A. program unless they have hit bottom. For practicing A.A.'s remaining eleven Steps means the adoption of attitudes and actions that almost no alcoholic who is still drinking can dream of taking. Who wishes to be rigorously honest and tolerant? Who wants to confess his faults to another and make restitution for harm done? Who cares anything about a Higher Power, let alone meditation and prayer? Who wants to sacrifice time and energy in trying to carry A.A.'s message to the next sufferer? No, the average alcoholic, self-centered in the extreme, doesn't care for this prospect—unless he has to do these things in order to stay alive himself. Under the lash of alcoholism, we are driven to A.A., and there we discover the fatal nature of our situation. Then, and only then, do we become as open-minded to conviction and as willing to listen as the dying can be. We stand ready to do anything which will lift the merciless obsession from us. From Twelve Steps and Twelve Traditions, chapter on Step 2.

CONCEPT TWO

The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

Do we have an understanding of history of the General Service Conference?

Mhat is a Conference Advisory Action? Does our home group's G.S.R., D.C.M., area delegate report back to the group on the highlights of the Conference and Conference Advisory Actions?

Is our group meeting its wider Seventh Tradition responsibilities? (Reprinted from the General Service Office Service Material SM F-131)

Tradition 2 - "For our group purpose there is but one ultimate authority a loving God as He may Himself in our group conscience. Our leaders are but trusted servants; they do not govern."

The unity of Alcoholics Anonymous is the most cherished quality our Society has. Our lives, the lives of all to come, depend squarely upon it. We stay whole, or A.A. dies. Without unity, the heart of A.A. would cease to beat; our world arteries would no longer carry the life-giving grace of God; His gift to us would be spent aimlessly. Back again in their caves, alcoholics would reproach us and say, "What a great thing A.A. might have been!" "Does this mean," some will anxiously ask, "that in A.A. the individual doesn't count for much? Is he to be dominated by his group and swallowed up in it?" We may certainly answer this question with a loud "No!" We believe theré isn't a fellowship on earth which lavishes more devoted care upon its individual members; surely there is none which more jealously guards the individual's right to think, talk, and act as he wishes. No A.A. can compel another to do anything; nobody can be punished or expelled. Our Twelve Steps to recovery are suggestions; the Twelve Traditions which guarantee A.A.'s unity contain not a single "Don't." They repeatedly say "We ought . . ." but never "You must!". To many minds all this liberty for the individual spells sheer anarchy. Every newcomer, every friend who looks at A.A for the first time is greatly puzzled. They see liberty verging on license, yet they recognize at once that A.A. has an irresistible strength of purpose and action... Those who look closely soon have the key to this strange paradox. The A.A. member has to conform to the principles of recovery. His life actually depends upon obedience to spiritual principles. If he deviates too far, the penalty is sure and swift; he sickens and dies. At first he goes along because he must, but later he discovers a way of life he really wants to live. Moreover, he finds he cannot keep this priceless gift unless he gives it away... Thus has it been with A.A. By faith and by works we have been able to build upon the lessons of an incredible experience. They live today in the Tuelve Transport an incredible experience. They live today in the Twelve Traditions of Alcoholics Anonymous, which—God willing—shall sustain us in unity for so long as He may need us. From Twelve Steps and Twelve Traditions, chapter on Tradition 2.

PROMISE TWO "We will not regret the past nor wish to shut the door on it." What man does not want to make peace with his past? How many of us enter recovery with a deep feeling of shame for how we have lived? How many of us are confused about what we have done and what that might mean about who we are?

Hello brothers and sisters, fellow seekers trudging the road! My name is Roger R. and I am an alcoholic.

I'm writing this note as a form of amends to those who were deemed "Oldsters" when I was a "newbie". I judged and condemned them as rigid, dull and set in their ways. I'm not the sharpest knife in the drawer so it took a while before I understood that they got old because they followed the AA path ("Rarely have we seen a person fail who has thoroughly followed our path"). Eventually I understood that they had experienced something that had not only kept them sober, but they also knew they could not keep it unless they gave it away; in some areas that simply meant to guard the path so others could find the same "mother lode". I hope you recognize these words as quotations from the BB and 12x12, the path as mapped out by our founders. I'm being facetious when I reference not being the sharpest knife as I recognize today that the journey from the head to the heart is long and perilous. I don't know either if I am worthy of being a guardian of the AA path at this point however, I do know that 36 years ago I was subject to a spiritual experience that set the foundation I needed to enjoy, at this point, 36 years of continuous sobriety:

After 4 months of attending AA meetings, two treatment centres, I drank for oblivion x 3 days. When I could not pour it down any longer, I felt overwhelmed by a state described in our literature as a place of incomprehensible demoralization; I couldn't drink because drinking brought me to the jumping off place and I could not not drink because I didn't know how. (Powerlessness) My intuition spoke loudly "get your donkey back to AA, they'll show you how to live sober". I came back and saw that I had not drank in those preceding four months because I attended meetings thereby I was being disciplined enough so I could hear what went on; I was being disciplined to pray, opening by the Serenity prayer and closing with the Our Father. I was still too full of myself to recognize and give thanks to the process I had been subject to but the relapse caved my EGO just a little and I began to hear what was said; what was demonstrated during those four months that saved my life; that made the difference, it gave me the courage to come back!

Eventually, I got to appreciate that when the founders first wrote the Steps they used the "I" word and found that it was too self-ish self-centered so they changed it to We. "We admitted" coincides very well with "Our", we are not alone. Our Father also indicates even if it only at the subliminal level as newcomers suffer from a particular sickness, a dis-ease nevertheless speaking to the subliminal indicates that we do this together, that everyone is accepted, loved and cherished no matter what. And, if we all have the same father, maybe, just maybe everyone will respect the other as one in the sibling line and not to be hit on in pursuit of gratifying basic instincts. The closing prayer also includes "Kingdom", in the spiritual world Kingdom simply means under the umbrella where S/HE can watch over, care and sustain those in the Kingdom; the congregation that have turned their will and their life over to the God of their understanding. The entire prayer is loaded with paradoxical meanings to be discovered!

Where am I going with all of this, well a few years ago when I was a Trustee, the Responsibility Statement was utilized in favor of the Lord's Prayer. That didn't sit well with me but I didn't want to make waves and there were no newcomers in attendance so why bother. Then at the District meeting, there it is again. Then at the group level there's a motion to axe the closing prayer out of what I have known as the path of AA. There are newcomers in the room that for the life of me I can't find one single element of that Responsibility Statement that could carry them between meetings, not one! There are a multitude of citations I can draw out of our literature that speaks clearly to prayer as the foundation of the AA program. If it does not appeal to the newcomer, those within 10 years of their first meeting, keep coming back more will be revealed. That person is still in the process of letting go of old ideas and until they let go absolutely, the result is nil. Then we have the Step Three, Seven and Eleven prayers and it says clearly that prayer on its own has merit, as does meditation, but when they're performed together, they become the foundation for living. Who would want to deny that to anyone?

In closing, my most cherished brothers and sisters, thanks for reading. The argument I've encountered is "AA is a spiritual program not a religious one". It also states that it is attraction rather than promotion, it does not require promoting AA as either or. My guides along the way informed me that AA was a spiritual program that will set your spirit free, free from all addictions and self-destructive behaviors. There are many more correlates but as learned - go back to the basics and here it is, in the booklet of Grapevine collections "Following the articles, the Grapevine printed a letter from Bill W. who wrote that "it is sometimes complained that the Lord's Prayer is a Christian document". He went on to write that "it only seems right that at least the Serenity Prayer and the Lord's Prayer be used in connection with our meetings. It does not seem necessary to defer to the feelings of our agnostic and atheist newcomers to the extent of completely hiding our light under a bushel".

Again, thank you for reading! Half measures availed us nothing!
