AS we work the first nine Steps, we prepare ourselves for the adventure of a new life. But when we approach Step Ten we commence to put our A.A. way of living to practical use, day by day, in fair weather or foul. Then comes the acid test: can we stay sober, keep in emotional balance, and live to good purpose under all conditions?

A continuous look at our assets and liabilities, and a real desire to learn and grow by this means, are necessities for us. We alcoholics have learned this the hard way. More experienced people, of course, in all times and places have practiced unsparing self-survey and criticism. For the wise have always known that no one can make much of his life until self-searching becomes a regular habit, until he is able to admit and accept what he finds, and until he patiently and persistently tries to correct what is wrong.

Tradition 10 "Alcoholics Anonymous has no opinion on outside issues; hence the A.A. name ought never be drawn into public controversy."

NEVER since it began has Alcoholics Anonymous been divided by a major controversial issue. Nor has our Fellowship ever publicly taken sides on any question in an embattled world. This, however, has been no earned virtue. It could almost be said that we were born with it, for, as one old-timer recently declared, "Practically never have I heard a heated religious, political, or reform argument among A.A. members. So long as we don't argue these matters privately, it's a cinch we never shall publicly."

As by some deep instinct, we A.A.'s have known from the very beginning that we must never, no matter what the provocation, publicly take sides in any fight, even a worthy one. All history affords us the spectacle of striving nations and groups finally torn asunder because they were designed for, or tempted into, controversy. Others fell apart because of sheer self-righteousness while trying to enforce upon the rest of mankind some millennium of their own specification. In our own times, we have seen millions die in political and economic wars often spurred by religious and racial difference. We live in the imminent possibility of a fresh holocaust to determine how men shall be governed, and how the products of nature and toil shall be divided among them. That is the spiritual climate in which A.A. was born, and by God's grace has nevertheless flourished.

What is alcoholism?

As A.A. sees it, alcoholism is an illness. Alcoholics cannot control their drinking, because they are ill in their bodies and in their minds (or emotions), A.A. believes. If they do not stop drinking, their alcoholism almost always gets worse and worse.

Spot-check inventory

Some additional questions that can be helpful in evaluating whether our actions may or may not be in conflict with the principles of humility and sacrifice that underlie our anonymity traditions:

- Is my posting about the message or the messenger?
- Am I carrying the A.A. message in the hopes of helping someone else, or am I simply "shouting from the rooftops"?
- Am I taking my story and affiliating it with political
- Am I being extra cautious about not identifying other A.A. members in photographs or statements?
- Am I avoiding the temptation to incite controversy through caustic argument or bullying others who may disagree with me?
- Am I providing helpful information about A.A. for those who may need our help?

Group Liability Insurance Call Out The Problem:

- Many meeting locations (i.e. churches) are now requesting proof of insurance coverage from tenants (i.e. AA group)
- AA groups are non legal entities that cannot easily acquire liability insurance.

Potential Solution:

- Central Office may be able to offer location specific coverage as a sub-policy under the office's insurance.
- The cost per group is estimated at ~ \$100/ year, which would need to be paid for by the group.

ON SPONSORSHIP

Should a sponsor recommend hospitalization?

The important thing to remember is that hospitalization is not part of the A.A. program and that a doctor, not a sponsor, is the person who should say whether it is required. Experienced sponsors are careful not to set themselves up as substitutes for doctors in dealing with any phase of alcoholism.

An A.A. oldtimer offers this reminder: Hospitalization or other professional care given to a newcomer "does not in any way lessen the responsibility of the A.A. member to carry the message in the best way possible, and to furnish good sponsorship. It is not good A.A. simply to dump an alcoholic into the lap of others because we do not have enough time, or because the alcoholic is troublesome and demanding. Most of us recall with gratitude the enduring patience and great kindness older members showed us when we were new ourselves."

AREA UPDATE

It is with gratitude and enthusiasm that I provide an update on my activities so far as Area 91 Panel 75 Delegate. I attended the 75th General Service Conference (GSC) in New York from April 27 to May 3, 2025. It was a remarkable and life changing experience. I am currently travelling the province delivering reports. Fortunately, it looks like I will be able to complete reports at all 19 Districts, with some of the reports being combined with 2, 3 or 4 Districts at a time.

I am learning a great deal throughout the report back process and enjoying the questions and conversations afterwards. Rather than a focus on the details from the GSC, the big picture concepts of unity, principles before personalities, the importance of the group conscience and trusting the process have been in the forefront. The details, including the outcomes of all the agenda items, can be found in the 2025 Conference Final Report when it is available.

I was fortunate to attend the International Convention in Vancouver from July 3 to 6, 2025. In addition to helping organize the Western Canada Regional Hospitality Suite and volunteering as a BC Place Greeter, I had the amazing opportunity to speak about the history, current struggles and successes of AA in Saskatchewan as part of the panel "Western Canada, Meet Your Neighbours". Thank you to all Area 91 members who generously participated in many ways at the International Convention, including attending, volunteering and chairing or speaking on panels.

INSTITUTIONS: Carrying the Message of Hope

My name is Sheila U. I am an alcoholic. It is a privilege to serve as your Institutions Trustee! I love my job. My term ends December 2026.

We carry the message of hope to 7 institutions. I am so happy to report we chaired over 150 meetings so far this year. Commitments to chair from 14 home groups and 12 individuals made this possible! I thank you for your service.

Background: Since the beginning in 1935, the Fellowship of AA has cooperated with treatment facilities. Bill W. himself was a product of a treatment facility-Towns Hospital in New York City. After he put together several months of sobriety, Bill W. returned to Towns to work with other alcoholics. This was keeping him sober. This was the beginning of AA's twelve step work in hospitals.

A surgeon from Akron, Ohio named Dr. Bob then entered the scene. He sobered up and realized the need for an alcoholism ward at St. Thomas Hospital, where he worked. With the loving assistance and dedication of Sister Ignatia, Dr. Bob established a ward for alcoholics; together, they reached over 5000 alcoholics.

The principle of carrying the message to other alcoholics was fundamental to the recovery and continued sobriety of AA's co-founders (Bill W. and Dr. Bob) and early AA members. Through the practice of this principle-the Twelfth step-the AA message has been carried around the world including at treatment centers.

"Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics! It works when other activities fail. This is our twelfth suggestion: Carry this message to other alcoholics! You can help when no one else can. You can secure their confidence when others fail." (c. 7, Big Book)

Institutions we serve:

<u>Larson House</u> (Brief Detox Unit and Social Detox Unit): Located at 201 Avenue O South. Serves Adults 18 years or older. On-site Addiction Counsellors, Emergency Medical Technicians, and Registered Nurses.12 bed unit for detox. 12 bed unit for social detox. AA meetings are on Mondays and Fridays at 8:00 PM.

<u>Calder Adult:</u> Located at 2003 Arlington Avenue (use main entrance). 4-week treatment plan for alcohol and drugs. 38 beds. AA meetings are on Tuesdays @ 8:00 PM.

<u>Calder Youth:</u> Located at 2003 Arlington Avenue (use north entrance). Serves youth 12-17 years of age. Youth detox 4-10 days. 6 beds. Youth treatment 28 days. 12 beds. AA meetings are on Fridays at 8:00 PM.

INSTITUTIONS: Carrying the Message of Hope (con't)

<u>Dube Centre:</u> Located at 103 Hospital Drive. Acute care inpatient services for youth & tamp; adults with major mental health problems. 64 beds. AA meetings are on the 1st and 3rd Monday of the month @ 7:00 PM.

<u>Carter House:</u> Located @ 601 Taylor Street West. Opened November of 2024. Family healing and recovery center. 3-month comprehensive treatment. Capacity for 20 families. AA meetings are on Thursdays @ 7:00 PM.

Saskatoon Tribal Council Wellness Centre: Located @ 415 Fairmont Drive. Drop in shelter facility for vulnerable people. 106 beds. AA meetings were held for 3 months then paused. We will revisit needs in the future. Our role now is to ensure AA literature is replenished and the AA meeting list is current.

Mustard Seed Shelter: Located @ 210 Pacific Avenue. Temporary emergency shelter. Opened April of this year. House-focused approach. Goal is to transition into long term housing. 40 beds. AA meetings were held on-site for 5 weeks. We will revisit the needs in the future, given that the permanent shelter is expected to open in the Caswell Hill area in 2026. Our role right now is to ensure the AA literature is replenished and the AA meeting list is current. A map to the Drinkle Building from the Shelter is available on-site should the clients want to walk to the noon meetings.

I am responsible: AA members who want to strengthen their sobriety or add more AA joy to their life are encouraged to carry the message of hope to the suffering alcoholics at institutions.
