### Step 2 “Came to believe that a Power greater than ourselves could restore us to sanity.”

THE moment they read Step Two, most A.A. newcomers are confronted with a dilemma, sometimes a serious one. How often have we heard them cry out, “Look what you people have done to us! You have convinced us that we are alcoholics and that our lives are unmanageable. Having reduced us to a state of absolute helplessness, you now declare that none but a Higher Power can remove our obsession. Some of us won’t believe in God, others can’t, and still others who do believe that God exists have no faith whatever He will perform this miracle. Yes, you’ve got us over the barrel, all right—but where do we go from here?”

Let’s look first at the case of the one who says he won’t believe—the belligerent one. He is in a state of mind which can be described only as savage. His whole philosophy of life, in which he so gloried, is threatened. It’s bad enough, he thinks, to admit alcohol has him down for keeps. But now, still smarting from that admission, he is faced with something really impossible. How he does cherish the thought that man, risen so majestically from a single cell in the primordial ooze, is the spearhead of evolution and therefore the only god that his universe knows! Must he renounce all this to save himself?

### Tradition 2 “For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.”

WHERE does A.A. get its direction? Who runs it? This, too, is a puzzler for every friend and newcomer. When told that our Society has no president having authority to govern it, no treasurer who can compel the payment of any dues, no board of directors who can cast an erring member into outer darkness, when indeed no A.A. can give another a directive and enforce obedience, our friends gasp and exclaim, “This simply can’t be. There must be an angle somewhere.” These practical folk then read Tradition Two, and learn that the sole authority in A.A. is a loving God as He may express Himself in the group conscience. They dubiously ask an experienced A.A. member if this really works. The member, sane to all appearances, immediately answers, “Yes! It definitely does.” The friends mutter that this looks vague, nebulous, pretty naive to them. Then they commence to watch us with speculative eyes, pick up a fragment of A.A. history, and soon have the solid facts.

## Snippets From AA Literature

### Who belongs to A.A.?

Like other illnesses, alcoholism strikes all sorts of people. So the men and women in A.A. are of all races and nationalities, all religions and no religion at all. They are rich and poor and just average. They work at all occupations, as lawyers and housewives, teachers and truck drivers, waitresses and members of the clergy. A.A. does not keep a list of members, but groups do report how many people belong to each one. From these reports, total A.A. membership is estimated at over 2,000,000.

### Questions and Answers About Anonymity

Q. I maintain a website and social media pages. At what level should I protect my anonymity on the Internet?

A. Publicly accessible aspects of the Internet such as websites featuring text, graphics, audio, and video can be considered the same as publishing or broadcasting. Unless password-protected, a website requires the same safeguards that we use at the level of press, radio, and film/video. Simply put, this means that A.A.s do not identify themselves as A.A. members using their full names and/or full-face photos. It is suggested that when A.A.s gather as A.A.s or as an A.A. group on social media and other similar platforms that these pages are set to "private" rather than "public."

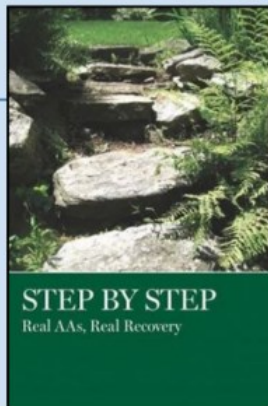

**ON SPONSORSHIP****How does sponsorship differ from Twelfth Step calls?**

A Twelfth Step call – visiting an alcoholic who has asked for help and talking about the A.A. program with them— may become the beginning of sponsorship, but by itself, it is not necessarily sponsorship. Sponsorship, with its continuing interest in another alcoholic, often develops when the prospect is willing to be helped, admits having a drinking problem, and decides to seek sobriety as a solution. Sponsorship is Twelfth Step work, but it is also continuing responsibility for helping a new-comer adjust to a way of life without alcohol.

What is Welcome Group?

Welcome Group is a weekly open speakers meeting that anyone can attend. (To make it easier for single parents to attend there is a side room for children). It is a one hour speakers meeting on Saturdays at 7:30-8:30 PM. There is an AA and an Al-Anon speaker for the evening that share their experience, strength and hope.

Welcome group may be a person's first meeting. They may be unsure whether they are an alcoholic. They may be fearful of a regular meeting or fearful to give their name and admit they are an Alcoholic in a room full of strangers. Welcome group is less stressful. They are not asked to give their name and can remain anonymous

Do you have friends, family or co-workers that are curious about the AA program and how it works? Welcome group is the perfect place for them to learn about both programs. The Al-Anon speakers are very helpful by sharing their experiences of living with alcoholics. Some attendees may find they may also need the Al-Anon program as solution to help them deal with the alcoholics in their life. There is also both AA and Al-Anon literature available at meetings.

It is also a great place to meet people in the fellowship and make new friends.

- The two week chairing opportunities will allow smaller groups to experience the joy of AA service that fulfills our primary purpose. To help the still suffering Alcoholic.

How A.A. Started

A.A. was started in 1935 by a New York stock-broker and an Ohio surgeon who had been desperately seeking a solution to their chronic drunkenness. To them, and to the millions who found relief by following their example, the recovery they found from alcoholism was nothing short of miraculous. They founded A.A. in an effort to help others who suffered from the disease of alcoholism and to stay sober themselves. A.A. grew with the formation of autonomous groups, first in the United States and then around the world.
